26 I. CORRUPTION WITH THE EUROPEAN OMBUDSMAN AND OTHER BODIES

27

28 I filed 3 complaints with the EU Ombudsman, which were well DOCUMENTED
29 COMPLAINTS ABOUT MISMANAGEMENT BY EU bodies, as well as evidence of
30 HARSH HUMAN RIGHTS VIOLATIONS RELATED TO OUTSIZED CORRUPTION IN FRANCE
31 (Ref 3.a., Ref 4, Ref 5, Ref 6 and Ref 7).

32

33 I received an answer by the EU Ombudsman wich is not only a careless and
34 baseless rejection of well documented complaints.

35 It is, in itself, DOCUMENTED CORRUPETION with the EU Ombudsman.

39 II. SOPHISTICATED CYBER ATTACK ON CRITICAL INFRASTRUCTURE OF THE
40 INTERNET IN THE EU

41

42 SIMULTANEOUSLY with this broken response from the EU Ombudsman, my web
43 site, in which the documented were made available, underwent a
44 sophisticated, two pronged CYBER ATTACK:

45

46 – On the one hand, my access to the data online was cut-off from within
47 my cloud provider (Ref 9).

48 – On the other hand, my domain name itself had its record made
49 permanently broken on several DNS server (Ref 8).

50

51 The latter attack, aiming directly at the domain which is my property,
52 requires either (most likely) the ability to introduce back doors in the
53 software managing DNS servers, or the ability to hack several DNS
54 servers on several continents at the same time.

55

56 In both cases, the attack required the CAPACITY TO COMPROMISE CRITICAL
57 INTERNET INFRASTRUCTURE within the EU.

58

59 This attack lead me to move my site in emergency on another domain name,
60 to which the references here point.

61

63

64 III. CRIMINAL ACTIVITY RELATED TO DISINFORMATION ABOUT POTENTIALLY FATAL
65 INDUSTRIAL POLICIES

66

67 The only motives for those criminal activities, in relation both to the
68 content of my complaints and my communication with the ombudsman can be
69 of two kinds:

70

71 – Extreme anticompetitive practices amounting to torture, outsized
72 corruption of officials, and murder of competitors.

73 – Disinformation about disastrous industrial policies, leading to
74 economic and ecological catastrophe down the road, as well as ill
75 conceived R&D priorities required for European Sovereignty on Digital
76 Technologies, based on deceptive argumentation by the European Research
77 Council (Ref 11).

78

79 In both cases , it is IMPERATIVE THE THE EU REACT WITH FORCE.

80

81 ACTUAL, OPEN, TRANSPARENT AND EXPLICIT DISCUSSION AND INQUIRIES MUST
82 PROCEED to determine the extent of the disinformation , rectify the R&D
83 and the Industrial Strategies , and characterize the related criminal
84 acts (Ref 10, Ref 12, Ref 13).
